

LOVE YOUR CAR RETAIL PROMOTION 2026 TERMS AND CONDITIONS

1. This competition ("Competition") is conducted by Repco Authorised Service (A division of GPC Asia Pacific Pty Ltd (ABN 97 097 993 283) of 22 Enterprise Drive Rowville 3178.
2. The (Promotion) commences at 12:01am on 01/08/2026 and closes 11:59pm AEST on 30/09/2026 ("Promotional Period").
3. The sections on How to Enter, Draw and Winner Notification, Prizes and Miscellaneous Provisions form part of these Terms and Conditions.
4. This Promotion is only open to Australian residents aged 18 years or older who have not been discovered to have breached these Terms and Conditions. Employees of the Promoter, Repco Australia, GPC Asia Pacific Pty Ltd, Repco Authorised Service centres (including workshop owners and employees), and the immediate family members of such persons are not eligible to enter this Promotion.
5. Entry into this Competition is deemed to be acceptance of these Terms and Conditions. The Promoter's decision not to enforce a specific restriction does not constitute a waiver of that restriction or of these Terms and Conditions generally.
6. HOW TO ENTER:

 - a. Entrants must have their car serviced at a Repco Authorised Service centre between 1 June and 30 September 2026 and provide proof of purchase on entry.
 - b. visit the website www.repcoservice.com and follow the links to the promotional entry page and complete all required information including describing in 25 words or less why they should win the love your car prize.
 - c. Agree to the term and conditions and ensure the entry is submitted via the online form before the promotion closes.
 - d. all entries must only be submitted online via the method as described.
 - e. No responsibility will be accepted by the Promoter for late, lost or misdirected entries. Incomplete or indecipherable entries will be deemed invalid.

PRIZES

Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.

Except for any liability that cannot be excluded by law, the Promoter (including their officers, employees and agents) excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity, loss of business or loss of goodwill or loss of profits); whether direct, indirect, special or consequential, arising in any way out of this Promotion, including without limitation, where arising out of the

following: any technical difficulties or equipment malfunction (whether or not under the Promoter's control); any theft, unauthorised access or third party interference;

- a. any entry or prize claim that is cancelled, delayed, interrupted, diverted, late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter or otherwise);
